#### Within the EU:

If desired, we perform registrations as the lead registrant. We create and update your registration dossiers and represent you at dossier and substance evaluations in the various working groups of the ECHA and national agencies.

#### **Outside the EU:**

If you want to distribute your product internationally, you must meet the requirements of chemicals laws in individual countries. The effort required here is considerable, as is the risk of being blocked from the market because of a lack of subject matter expertise. We are familiar with the laws in the individual countries (Turkey: KKDIK; South Korea: K-REACH; Russia: Eurasian REACH). 
